## Terms and conditions

You must:

- Be a 2023 member of CF Community Care
- Have CF or be the primary parent / carer of a child aged under 18 years who has CF

**Medical and physiotherapy equipment** can be borrowed for free for a maximum initial period of one month unless otherwise arranged.

**Oxygen concentrators** can only be borrowed if you have a referral from your Respiratory Physician.

You will need to supply your own tubing, masks, handsets, and medicine cups when borrowing nebuliser pumps and oxygen concentrators.

All CF Community Care equipment should be collected from and returned to the CF Community Care office by the agreed date. If the equipment is not returned by the agreed date:

- you will be charged \$50 per month, or part thereof until the equipment is returned, AND
- you will not be able to access any Community Care programs and services until the equipment is returned.

You agree to keep the equipment clean and in good condition while on loan.

- All equipment faults must be reported immediately to CF Community Care.
- You will be charged for all repair charges and / or replacement costs other than for reasonable wear and tear.

Bookings for loan equipment can be made up to three months in advance.

The equipment remains the property of CF Community Care at all times and cannot be sold, hired, loaned, modified or repaired without permission from us.

A completed application form must be provided.
